## **Boat Rack Policy**

Due to the limited amount of spaces on the Boat Rack(s), the Association will be conducting an annual lottery to determine which members can occupy such space between the months of October 1<sup>st</sup>, through September 30<sup>th</sup>. There will be a \$50.00 annual fee to occupy a boast rack, passed by the Board at the December 2020 meeting. Please return the Boat Rack Lottery application along with \$50.00 fee (made out to TWPOA). If you do not win a boat rack, your \$50.00 will be returned to you. We are accepting boat rack applications up to August 1<sup>st</sup>.

- Boats occupying boat racks will be no smaller than 10 feet and not longer than 16 feet length.
- All boats must be registered with the Tink Wig Management office. The Association has new "Red" stickers for all watercraft that can be picked up at the office.
- Boat rack spaces not actually occupied by April 1<sup>st</sup>, will be considered in default leading to the lottery winners having their application fee returned to them. These spaces will be then offered to the next alternate lottery winner on the list.
- Boats racks are not transferable from owner to owner.
- If you choose to vacate your boat rack during October 1<sup>st</sup> and September 30<sup>th</sup>, please notify the office so we can award that space to the next alternate lottery winner on the list.
- If any member fails to remove their boat from the rack after October 1<sup>st</sup> due to their name not being called in the lottery, they will be charged \$1.00 a day storage fee should the boat have to be removed.
